Delisting Determination, The Nasdaq Stock Market, LLC, March 3, 2023, Waitr Holdings Inc.

The Nasdaq Stock Market LLC (the Exchange) has determined to remove from listing the common stock of Waitr Holdings Inc., effective at the opening of the trading session on March 13, 2023.

Based on review of information provided by the Company, Exchange Staff determined that the Company no longer qualified for listing on the Exchange pursuant to Listing 5450(a)(1).
